Each issue contains at least one feature article and technical article note plus editorials, humor items and more.

**Specifications:** Advertising artwork should be in TIF, JPG or EPS format at a minimum full size resolution of 300 dpi. If the file size is greater than 1 MB in size and you wish to send it via e-mail, please contact the **FastTIMES** editor for information on the file transfer site.

**Payment Policy:** Payment will be due on the date the issue is distributed via mail or the Internet. An invoice will be sent with a tear sheet of the advertisement. Payment by company check is preferred and encouraged. Visa, MasterCard, AMEX and Discover credit cards are accepted.
